

PUBLIC SERVICE COMMISSION, WEST BENGAL

Applications in the prescribed format given at the Commission's website at www.pscwbapplication.in are invited from Indian citizens and such other nationals as are declared eligible by Govt. of India for recruitment to the under mentioned posts. Posts at Sl. No. 1 & 2 are permanent and post at Sl. no.3 is temporary but likely to be permanent.

N.B. ABILITY TO READ, WRITE AND SPEAK IN BENGALI IS AN ESSENTIAL QUALIFICATION FOR RECRUITMENT TO THE POSTS AND SERVICE MENTIONED BELOW. PROVIDED THAT THE SAID COMPULSORY REQUIREMENT OF KNOWLEDGE IN BENGALI INCLUDING THE ABILITY TO READ, WRITE AND SPEAK IN BENGALI FOR RECRUITMENT TO THE FOLLOWING POSTS, SHALL NOT BE APPLICABLE TO THOSE CANDIDATES WHOSE MOTHER TONGUE IS NEPALI. THIS WILL BE TESTED AT THE TIME OF INTERVIEW.

QUALIFICATIONS

ESSENTIAL : i) M.Sc. degree in Chemistry or M.Sc.(Agriculture) with Agricultural Chemistry and / or Soil Science from a recognized University/ Institute or equivalent.
ii) Two years' experience in Social Science , relaxable for well-qualified candidates.

Desirable: Knowledge of Botany

AGE: Not more than 36 years as on 01.01.2018, relaxable for well-qualified candidates.

2. ASSISTANT DIRECTOR OF AGRICULTURAL MARKETING (ADMINISTRATIVE) IN THE WEST BENGAL AGRICULTURAL SERVICE (MARKETING) UNDER THE AGRICULTURAL MARKETING DEPARTMENT, GOVERNMENT OF WEST BENGAL.

NO. OF VACANCY: TWO (ONE EACH RESERVED FOR ST AND OBC CATEGORY 'A' CANDIDAES)

QUALIFICATIONS :-

ESSENTIAL : i) Masters' Degree or Honours Degree in Economics or Statistics or Agriculture or Commerce or equivalent qualification from a recognized University,
ii) Three years' experience in Agricultural Marketing in any field related to Agricultural Marketing,
iii) Knowledge of Bengali / Nepali – spoken & written

DESIRABLE: i) A certificate or Diploma in Agricultural Marketing from a recognized Institute or Government.
ii) Degree in Law.

AGE: Not more than 36 years as on 01.01.2018, relaxable for the candidates having higher qualifications and / or longer experience than those prescribed.

3. ART MISTRESS, DOW HILL GIRLS' SCHOOL, KURSEONG IN WEST BENGAL GENERAL SERVICE UNDER THE SCHOOL EDUCATION DEPARTMENT, GOVT OF WEST BENGAL

QUALIFICATIONS

Essential:

(i) Degree or Diploma (5 year course) from a recognized school of Art or equivalent;
(ii) Experience as a practicing artist;
(iii) 3 years' teaching experience in a recognized Educational Institute, preferably in a School &
(iv) Ability to teach in English medium.

[Items (ii) & (iii) relaxable for an otherwise well-qualified candidate]

Desirable:

(i) Good power of expression in Bengali and Nepali – spoken and written &
(ii) Proficiency in crafts.

Note :

- (I) Age is relaxable for otherwise well-qualified candidates and for persons holding substantive appointment in the teaching branch of the Education Department, West Bengal.
- (II) Selected candidates whose mother-tongue is not Bengali will have to pass the Departmental Examination in Bengali before confirmation. Men are unsuitable for the teaching post of Mistress.
- (III) The minimum qualifications are relaxable at the discretion of the Public Service Commission, West Bengal for otherwise well-qualified candidates in cases no candidate possessing the minimum qualifications is available.
- (IV) Free partly furnished quarters will also be provided under certain conditions.

AGE :Not more than 36 years as on 01.01.2018.

PAY (For the posts at sl. nos. 1, 2 & 3):

Rs.15, 600/- – Rs.42, 000/- (P.B. 4A) plus Grade Pay Rs. 5, 400/-.

Fee: Rs. 210/- (Rupees two hundred ten) only. In addition to that, the candidate will be charged as follows:

- (i) For online payment through debit/credit cards: Convenience fee 1% of the examination fee subject to a minimum of Rs. 5/- (Rupees Five) only plus 18% G.S.T. on convenience fee.
- (ii) For online payment through net banking: Convenience fee of Rs. 5/- (Rupees Five) only plus 18% G.S.T. on convenience fee.
- (iii) For offline payment through bank counter: Service Charge of Rs. 20/- (Rupees Twenty) only.

S.C./S.T. candidates of West Bengal and Persons with disabilities (P.W.D.) having physical disability of 40% and above are not required to pay any fee. BC candidates of West Bengal are, however, required to pay usual fee as aforesaid. NO EXEMPTION OF FEE IS AVAILABLE TO S.C./S.T. CANDIDATES OF OTHER STATES AND B.C. CANDIDATES. No claim for refund of the fee will be entertained nor will it be held in reserve for any other examination.

INFORMATION

1. Candidates who wish to apply for more than one category of posts should submit separate Application along with requisite fees for each.
2. SUBMISSION OF MORE THAN ONE APPLICATION FOR ONE PARTICULAR POST IS STRICTLY FORBIDDEN. THE CANDIDATURE OF A CANDIDATE WHO SUBMITS MORE THAN ONE APPLICATION FOR ADMISSION TO THE SELECTION PROCEDURE, WILL BE CANCELLED EVEN IF HE/SHE IS ADMITTED TO THE SAME.
3. The qualifications prescribed in the advertisement are as per the notified recruitment rules issued by Government.
4. All the degrees/diplomas/certificates mentioned in the advertisement must have been obtained from recognized Universities/Institutions.
5. The prescribed 'essential qualifications' are the minimum and mere possession of the same does not entitle applicants to be called in for the interview. Where the number of applications received in response to the advertisement is large and it is not convenient or possible for the Commission to interview all the applicants the Commission may restrict the number of candidates for interview to a reasonable limit on the basis of either higher qualifications in the relevant subjects/higher standard of marks/grade obtained in the essential qualifications or experience in relevant field higher than the minimum prescribed in the advertisement or on the basis of a Screening Test/Written Test. The Commission may fix qualifying cut-off marks for all the categories of the vacancies in each level of examination, i.e. written, interview and aggregate.
IN THE CASES OF SCREENING TEST/ WRITTEN TEST, CANDIDATES SUFFERING FROM BLINDNESS OR LOW VISION AND LOCO-MOTOR DISABILITY OR CEREBRAL PALSY WITH WRITING EXTREMITY WILL BE ALLOWED THE HELP OF A SCRIBE, IF REQUIRED. THE SCRIBE SHOULD NOT POSSESS EDUCATIONAL QUALIFICATION HIGHER THAN THE REQUISITE QUALIFICATION FOR THE POST.
If sufficient number of candidates with prescribed age limit is available for selection for a particular post, the commission may exercise its discretion not to relax upper age limit of the candidate(s) even if the provision for such relaxation is laid down in the advertised criteria.
6. In cases where no Division/Class is awarded and only grading is done, exact percentage of marks and conversion formula adopted are to be mentioned with documentary evidence, if required.
7. Where experience of a number of years is prescribed as an item of qualification this would mean only experience/research experience gained in full time employment/research in the relevant field within the closing date of receipt of applications.
[Certificate(s) from the Head(s) of the Organization(s)/Department(s) or Competent Authority for the entire experience claimed, clearly mentioning the duration of employment (date, month and year) and field of experience indicating basic pay and consolidated pay must be obtained. The certificate(s) should also mention the nature of duties performed/experience obtained in the post(s) with duration(s)].

8. Besides pay, the posts carry allowances as admissible.
9. The benefits of reservation of vacancies and upper age concession up to 5 years are admissible only to S.C. and S.T. candidates of West Bengal and up to 3 years to O.B.C. (category 'A' & 'B') candidates of West Bengal. S.C., S.T. and B.C. candidates of other States may apply for unreserved vacancies as general candidates. Such benefits are also available up to the age of 45 years for Persons with disabilities.
- (a) A candidate claiming to be S.C., S.T., B.C. or persons with disabilities (40% and above) must have a certificate in support of his/her claim from a competent authority of West Bengal as specified below:

For S.C., S.T. and B.C. candidates:

- (i) In the district, the Sub-Divisional Officer of the Sub-Division concerned, and
- (ii) In Kolkata, the District Magistrate, South 24-Parganas or such Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas, on behalf and the District Welfare Officer, Kolkata and Ex-officio Joint Director, Backward Classes Welfare.

(c) S.C., S.T., O.B.C. OR PERSON WITH DISABILITY CERTIFICATE MUST BE OBTAINED WITHIN THE CLOSING DATE OF RECEIPT OF APPLICATIONS AND NO CLAIM IN THIS REGARD WILL BE ENTERTAINED AFTERWARDS.

10. CANDIDATES MUST FULFIL THE ESSENTIAL QUALIFICATIONS BY THE CLOSING DATE.
11. **All requisite certificates regarding educational qualifications, proof of age, other relevant experience certificates and other requisite documents must be furnished as and when required by the Commission.**
12. If at any stage even after issue of a letter of recommendation for appointment a candidate is found ineligible in terms of the advertisement his/her candidature will be cancelled without further reference to him/her.
13. CANVASSING IN ANY FORM WILL DISQUALIFY THE CANDIDATURE .
